## **Canonica lawsuit**

The time period to file an appeal of the summary judgement has now passed. Therefore, it is unlikely that a Washington State appeal court would hear arguments on the merits of the lawsuit. TRC received the final legal bill of \$4583 for the lawsuit. The total cost of TRC's legal services was \$10,108.

## **Canonica's Facebook Accounts and other Nuisances**

As reported earlier, TRC continues to monitor all six of his Facebook pages. Although there are many disparaging remarks made about myself, other members of TRC, and of TRC itself, at this time there is little reason to take any legal action.

Also as reported earlier, TRC maintains its no trespass order against Canonica. We are waiting to hear from the Washington state prosecutor on whether charges will be filed against Canonica in relation to his trespass pass in early June 2016.

## **Turner Property and Boundary**

As reported earlier, TRC sent an email message to Mr. Turner. Mr. Turner replied and invited us to discuss some minor amendments to eastern expansion. There was some discussion about a possible fence between the two properties. As a result, the vice president development is exploring costs and opportunities associated with Mr. Turner's fence proposals.

There was no discussion about property acquisition. However, he did acknowledge receiving TRC's reports regarding land usage and estimated values of his property. Depending on the fence and amendment discussions, TRC will be able to better assess the likelihood of an acquisition.

## **Picnic tables**

Notwithstanding the best efforts of the vice president of operations, the contractor responsible for supplying TRC with new picnic table failed to deliver in June. Because TRC paid a \$1000 deposit, efforts were made by the treasurer to obtain a refund. TRC's options included the possibility of a small claims action. The treasurer agreed to see if the original order could be fulfilled to minimize costs. Further discussions with the contractor left open that possibility. My office sent him an email offering him the last opportunity to provide the tables by July 22, 2016. Should he fail to deliver, or contact TRC before July 22, 2016, TRC will consider a small claims action against the contractor to recover the \$1000.

TRC continues to receive emails from Dean Carey, largely around requests to come onto TRC property for various reasons. Below is a copy of the last of those emails. I have bolded a section for which the Board may wish to consider.

Good afternoon Dean

The Board has not authorized the Executive Committee to act on your requests. Therefore, **your requests will be put to the board at the next meeting**, which is on July 16th. I will advise you on the Board's response, if there is any.

The Vice President of Operations advises that enforcement of the Board-imposed suspension and its corresponding ban on your presence at TRC remains unchanged. Furthermore, you are reminded that under the terms of your suspension, you are not permitted to be on TRC property, unless there is a life-threatening reason. This remains in effect for the remainder of the 2016 camping season.

From your emails it appears that you wish to remain in contact with some TRC members and to manage your belongings that are still on TRC property. Of course, you are free to communicate with whomever you choose at TRC, you simply cannot be on TRC property when you do so. Likewise, whom amongst the TRC membership you choose to manage your belongings is your business. Again, you cannot be on TRC's property.

Dean, your reference to needing access to the phone for an emergency appears dubious. Of course, the pay phone is available for 911 calls, as it would be for any non-member who has a life-threatening situation and was in need of police, fire department or ambulance services. That said, it is not available to you for other types of phone calls that you may perceive as being an emergency. Therefore, TRC suggests that you plan your travels and affairs to the neighbouring TRC area accordingly.

Dean, you mentioned "being up at the cabin" in your second email. Because TRC has a cabin on its property, we trust that you are not implying that TRC is, notwithstanding your suspension, granting you access to that cabin. Rather, your reference to 'the cabin' was a reference to the structure on the Turner property. Of course, TRC has no say about your activity on the Turner property.

You posed a couple of questions with an implication that there is a standard rule that is applicable to each case. However, I would point out that each case of discipline differs in its terms. Under the terms of your suspension, unless there is a change to the terms of your suspension or there is a life threatening

situation, you are not permitted to attend the AGM or board meetings.

Your question about reclaiming the site coordinator position following the suspension is being referred to committee for further study. I will advise you of TRC's response, once it is ready.
